

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(To override veto of Resolution No. 369-86)

RES. NO. 379-86

1 WHEREAS, The Tohono O'odham Legislative Council did by Resolution No. 369-86
2 authorize the renewal, for a one year period, a contract between the
3 Town of Gila Bend and the Tohono O'odham Nation wherein the Town of
4 Gila Bend agrees to provide Fire Protection to the village of San Lucy;


7 WHEREAS, Upon presentation of Resolution No. 369-86 to the Chairman of the
8 Tohono O'odham Nation he did disapprove thereof and returned it to the
9 Council with his objections in accordance with the provisions of
10 Article VII, Section 5 of the Constitution of the Nation; and

12 WHEREAS, The Council has reviewed the Chairman's objections and after consider-
13 ation again voted to pass Resolution No. 369-86.


14 NOW, THEREFORE, BE IT RESOLVED that the Council does hereby override the
15 Chairman's veto of Resolution No. 369-86, by a vote of two-thirds (2/3)
16 of the votes cast.

17 The foregoing resolution was passed by the Tohono O'odham Council on the 6th
18 day of August, 1986, at a meeting at which a quorum was present with a vote of
19 1008.0 for; 499.0 against; 133.0 not voting; and 01 absent, did override the
20 Chairman's veto of Resolution No. 369-86, pursuant to the powers vested in the
21 Council by Section 5 of Article VII of the Constitution of the Tohono O'odham
22 Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved
23 by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March
24 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
