1 WHEREAS, In review of the proposed agenda for this meeting, there was dis-
2 cussion pertaining to one of the agenda items, specifically the
3 Executive Committee; and

4 WHEREAS, The Legislative Council set aside August 15, 1986 to discuss the
5 issues proposed by the Executive Committee, namely the Committee
6 Structure, and the resolution regarding the Tribal Attorney's in-
7 volvement in all three Branches of Government.


8 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that the item on the
9 Executive Committee is scheduled to be a Special Session of this
10 Council on August 15, 1986 and all Councilmembers are to bring their
11 handouts and information to this meeting.

12 The foregoing resolution was passed by the Tohono O'odham Council on the 8th
13 day of August, 1986, at a meeting at which a quorum was present with a vote of
14 1640.0 for; -0- against; -0- not voting; and 01 absent, pursuant to the powers
15 vested in the Council by Section 1 (b) of Article VI of the Constitution of the
16 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
17 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
18 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
19 1934 (48 Stat. 984).
