3 cover anticipated cost and expenses; and


4 WHEREAS, The Gu Achi District Council did adopt and approved the proposed a-

7 mended budget and approves of same.



13 day of August, 1986, at a meeting at which a quorum was present with a vote of
14 1640.0 for; -0- against; -0- not voting; and 01 absent, pursuant to the powers
15 vested in the Council by Section 1(d/3) of Article VI of the Constitution of the
16 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
17 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
18 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
19 1934 (48 Stat. 984).
