

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of six month interim Tribal Budgets FY 87)

RES. NO. 384-86

1 WHEREAS, The Budget & Finance Committee is responsible for recommending an  
2 annual budget to the Tohono O'odham Legislative Council as authorized  
3 by Resolution No. 31-79; and

4 WHEREAS, The Budget & Finance Committee did review proposed Budgets for FY 87  
5 in the amount of \$3,522,243.00 and reviewed anticipated revenues at  
6 \$3,596,500.00; and

7  
8 WHEREAS, Noranda Mine has not indicated whether they will continue operating  
9 the Mine, which does pay royalties to the Nation; and

10 WHEREAS, The interest rates on the Nation's investments have been very low;  
11 and

12 WHEREAS, The Budget & Finance Committee believes it is in the best interest of  
13 the Nation that an interim six month budget be approved for all Tribal  
14 funded programs including Enrollment, Water Commission and Water  
15 Management due to unclear financial forecasts; and

16  
17 WHEREAS, The Budget & Finance Committee further recommends that a financial  
18 analysis be made before the end of the six month period.

19 NOW, THEREFORE, BE IT RESOLVED that the Council approves the attached budgets  
20 for Enrollment, Water Commission and Water Management on a six month  
21 basis.

23 BE IT FUTHER RESOLVED by the Tohono O'odham Legislative Council that it adopts  
24 an interim six month Tribal budget for FY 87 in the amount of  
25 \$1,776,116.00 and based on projected revenues estimated at  
26 \$1,723,250.00 and supplemented by the Enrollment, Water Commission  
27 and Water Management funding.

28 BE IT FURTHER RESOLVED that Miss Tohono O'odham and Rodeo & Fair Budgets will  
29 not be subject to this limitation of an interim budget.

30 BE IT FURTHER RESOLVED that a financial analysis will be conducted before the  
31 six month ends.

1 The foregoing resolution was passed by the Tohono O'odham Council on the 8th  
2 day of August, 1986, at a meeting at which a quorum was present with a vote of  
3 1640.0 for; -0- against; -0- not voting; and 01 absent, pursuant to the powers  
4 vested in the Council by Section 1 (d) (3) of Article VI of the Constitution of  
5 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
6 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
7 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
8 1934 (48 Stat. 984).
