BE IT FURTHER RESOLVED that, upon completion of all appeals from this determination or upon expiration of the time allowed for such appeals, as provided in Art. IX, Sec. 2 of the Enrollment Ordinance, the names of the foregoing persons who failed to appeal or to succeed in their appeal shall be removed from the membership roll of the Tohono O'Odham Nation.

The foregoing resolution was passed by the Tohono O'Odham Council on the  $\underline{14th}$  day of  $\underline{August}$ , 1986, at a meeting at which a quorum was present with a vote of  $\underline{563.5}$  for;  $\underline{880.5}$  against;  $\underline{196.0}$  not voting: and  $\underline{-01}$ - absent, pursuant to the powers vested in the Council by Section 1 (h) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
