## RESOLUTION OF THE TOHONO O'ODHAM COUNCIL (Revocation of Membership in Tohono O'Odham Nation)

RES. NO. 391-86

HEREAS, Article II, Sec. 3 of the Constitution of the Tohono O'Odham Nation provides that membership in the Nation, and all rights deriving therefrom, shall be lost or relinquished if a person is or becomes enrolled as a member in another Indian nation, tribe, community or band; and WHEREAS, the Enrollment Committee has determined that the following person(s) who are enrolled as members of the Tohono O'Odham Nation are also enrolled as member(s) in another Indian nation, tribe, community or band, namely:

HEREAS, the Enrollment Committee did serve notice upon the foregoing person(s) that they must either relinquish membership in such other Indian nation, tribe, community or band, or relinquish or lose membership in the Tohono O'Odham Nation in accordance with the provisions of Art. IX Sec. 2 of the Enrollment Ordinance; and

WHEREAS, the foregoing person(s) did not relinquish membership in such other

Indian nation, tribe, community or band, and the Enrollment Committee

has therefore recommended that their membership in this Nation be re
voked by this Council; and

WHEREAS, the Enrollment Committee did serve written notice of its recommendation upon the foregoing person(s) or, if a minor or incompetent, upon their parent(s), guardian or other person legally authorized to act on their behalf, as required by Art. IX, Sec. 2 of the Enrollment Ordinance, and this Council has reviewed the Committee's recommendation and all evidence presented, and from such evidence finds that the foregoing person(s) are enrolled as members of this Nation and are

also enrolled as members of another Indian nation, tribe, community or

> band; that they were given an opportunity to relinquish membership in such other nation, tribe, community or band as required by Art. II,

Sec. 3 of the Constitution of the Tohono O'Odham Nation but have failed or refused to do so, and that their membership in the Tohono O'Odham Nation must therefore be revoked.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does hereby revoke the membership in this Nation of the foregoing person(s) and that the Enrollment Committee serve notice of this determination in accordance with Art. IX, Sec. 2 of the Enrollment Ordinance.

BE IT FURTHER RESOLVED that, upon completion of all appeals from this determination or upon expiration of the time allowed for such appeals, as provided in Art. IX, Sec. 2 of the Enrollment Ordinance, the names of the foregoing persons who failed to appeal or to succeed in their appeal shall be removed from the membership roll of the Tohono O'Odham Nation.

The foregoing resolution was passed by the Tohono O'Odham Council on the  $\underline{14th}$ day of August, 1986, at a meeting at which a quorum was present with a vote of  $\underline{1286.5}$  for;  $\underline{232.0}$  against;  $\underline{121.5}$  not voting: and  $\underline{-0-}$  absent, pursuant to the powers vested in the Council by Section 1 (h) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
