11 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above
12 named applicants are eligible for enrollment as members of the
13 Tohono O'odham Nation under Section 1 (a) or (b) of Article II of the
14 Constitution of the Tohono O'odham Nation, and that their applications
15 are approved, as herein above indicated.

16 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of
17 the Tohono O'odham Nation reduce this final determination in writing
18 regarding each of the foregoing applications for enrollment in ac-
19 cordance with Section 3 (c) of Article III of the Enrollment Ordi-
20 nance; give notice of this Council's determination in accordance with
21 Section 4 of Article III of the Enrollment Ordinance; and place the
22 names of each applicant upon the membership roll of the Tohono O'odham
23 Nation in accordance with Aritcle V of the Enrollment Ordinance.

25 The foregoing resolution was passed by the Tohono O'odham Council on the 14th
26 day of August, 1986, at a meeting at which a quorum was present with a vote of
27 1581.5 for; -0- against; 58.5 not voting; and -0- absent, pursuant to the
28 powers vested in the Council by Section 1 of Article II and of Section 1 (h) of
29 Article VI of the Constitution of the Tohono O'odham Nation, adopted by the
30 Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy
31 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
32 Section 16 of the Act of June 18, 1934 (48 Stat. 984).
