

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

(Adoption into the Tohono O'odham Nation)

RES. NO. 403-86

1 WHEREAS, BERNAL, Johnny G. JR.; has made application for adoption in the Tohono  
2 O'odham Nation pursuant to Section 2 of Article II of the Constitution  
3 of the Tohono O'odham Nation; and

4 WHEREAS, The Enrollment Committee has reviewed this respective application, has  
5 made a final determination that he is one-half 1/2 degree or more of  
6 Papago-Tohono O'odham Indian blood, and have made a recommendation to  
7 the Tohono O'odham Council that this application be approved, all in  
8 accordance with the provisions of the Enrollment Ordinance; and

9 WHEREAS, The Tohono O'odham Council has reviewed the recommendation of the En-  
10 rollment Committee and the evidence submitted in support of the  
11 individual application.


12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that the appli-

14 97-ND-86\* BERNAL, Johnny G. JR.


15 is hereby approved and he is hereby adopted into membership of the

18 day of August, 1986, at a meeting at which a quorum was present with a vote of  
19 1523.0 for; -0- against; 117.0 not voting; and -0- absent, pursuant to the  
20 powers vested in the Council by Section 2 of Article II and Article VI Section  
21 1(h) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
22 O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant  
23 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
24 16 of the Act of June 18, 1934 (48 Stat. 984).
