NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that the application for adoption filed by:

97-ND-86* BERNAL, Johnny G. JR.

is hereby approved and he is hereby adopted into membership of the Tohono O'odham Nation.

The foregoing resolution was passed by the Tohono O'odham Council on the 14th day of August, 1986, at a meeting at which a quorum was present with a vote of 1523.0 for; -0- against; 117.0 not voting; and -0- absent, pursuant to the powers vested in the Council by Section 2 of Article II and Article VI Section 1(h) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
