

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Committee Structure Recommendation and Option)

RES. NO. 405-86

1 WHEREAS, The Executive Committee of this Council did submit several recommen-  
2 dations and Options for the Council to take into consideration in  
3 restructuring of Committees, Boards and Commissions; and

4 WHEREAS, The Committee did discuss some of the recommendations and options as  
5 presented; and

6 WHEREAS, The Council has reviewed such recommendations and has modified the  
7 proposed Committee Structure; and


8 WHEREAS, It is in the best interest of the Nation that consolidation of certain  
9 Committees take place.

10 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that it hereby adopts  
11 the following:


- 12 1. The Appropriations Committee function within itself as in prior  
13 years
- 14 2. The Trust Committee be absorbed by the Budget & Finance Committee
- 15 3. The O.E.D.P. be absorbed by the Commerce Committee
- 16 4. The Mining Committee be absorbed by the Natural Resources  
17 Committee.

19 The foregoing resolution was passed by the Tohono O'odham Council on the 15th  
20 day of August, 1986, at a meeting at which a quorum was present with a vote of  
21 1640.0 for; -0- against; -0- not voting; and -01- absent, pursuant to the  
22 powers vested in the Council by Section 1(a) of Article VI of the Constitution  
23 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January  
24 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian  
25 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of  
26 June 18, 1934 (48 Stat. 984).


1 Said Resolution was submitted for approval to the office of the Chairman of the
