

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting recommendation to declare a moratorium)

RES. NO. 407-86

1 WHEREAS, The membership of the Standing Committee is composed of Chairman/
2 Chairwomen of the Tohono O'odham Nation's Standing Committees, Boards
3 and Commission's; and

5 WHEREAS, The Standing Committee is charged to work on developments and negoti-
6 ations concerning the Proposed Development at San Xavier by the Santa
7 Cruz Properties, Inc.; and futher charged to develop appropriate
8 goals and objectives; and

9 WHEREAS, The Standing Committee, as a result of reviewing data relating to the
10 Proposed Development, is concerned about critical and crucial issues
11 that will directly impact the Tohono O'odham Nation; and


13 WHEREAS, The Standing Committee did submit to the Tohono O'odham Legislative
14 Council a statement addressing those issues; and

15 WHEREAS, The Tohono O'odham Legislative Council did acknowledge and agree with
16 the Standing Committee's recommendations involving commercial and large
17 scale non-Indian residential development within the Nation.


18 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that it hereby
19 declares a moratorium on all commercial and large scale non-Indian
20 residential development on all lands of the Nation.

22 The foregoing resolution was passed by the Tohono O'odham Council on the 27th
23 day of August, 1986, at a meeting at which a quorum was present with a vote of
24 961.0 for; 610.0 against; 69.0 not voting; and 01 absent, pursuant to the
25 powers vested in the Council by Section 1c(2) and i(1) of Article VI of the
26 Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).






