

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Voiding signatures)

RES. NO. 408-86

1 WHEREAS, The Legislative Council did hear the preliminary report from the  
2 Standing Committee of this Council concerning the proposed development  
3 of the San Xavier Tucson Planned Community; and

4 WHEREAS, Councilman Tony Felix, representative from San Xavier District, did  
5 entertain a motion as follows:

6 That we the Governing Body of the Tohono O'odham Nation hereby order,  
7 declare, and direct that any and all signatures of any landowner,  
8 allottee, the heirs or decedents, any person having authority to act  
9 in the best interest of any such landowner or allottee, or any person  
10 having an interest in any allotment at San Xavier be null and void.

11 That any person having signed any lease agreement, a Power of  
12 Attorney, and any other legal document with Santa Cruz Properties  
13 shall not be bound to any and all terms of such legal document.


14 Motion amended, So in behalf of all my people who are against this  
15 project, that the proposed land development by Santa Cruz Properties  
16 be disapproved, terminated, and declared null and void; and

17 WHEREAS, Councilman Felix did review a Statement for the record to the Legis-  
18 lative Council and requested that it be attached with this resolution.

19 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that it hereby  
20 approves that all agreements and legal documents made with Santa Cruz  
21 Properties be declared null and void.

23 The foregoing resolution was passed by the Tohono O'odham Council on the 27th  
24 day of August, 1986, at a meeting at which a quorum was present with a vote of  
25 490.5 for; 898.5 against; 251.0 not voting; and 01 absent, pursuant to the  
26 powers vested in the Council by Section 1c(2) of Article VI of the Constitution  
27 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January  
28 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian  
29 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of  
30 June 18, 1934 (48 Stat. 984).
