

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Rejection of Santa Cruz Properties, Inc. Proposal)

RES. NO. 409-86

1 WHEREAS, The Tohono O'odham Legislative Council did meet on August 27, 1986 to
2 complete the Environmental Impact Statement Report by Randall Morrison,
3 Real Estate Services, Phoenix Area Office; and

4 WHEREAS, The Tohono O'odham Legislative Council also received a preliminary
5 report from the Standing Committee charged to work on developments
6 and negotiations concerning the proposed Development at San Xavier by
7 the Santa Cruz Properties, Inc.; and further charged to develop ap-
8 propriate goals and objectives; and

9 WHEREAS, The Tohono O'odham Legislative Council, having heard from the Standing
10 Committee, has concluded that the proposed San Xavier Tucson Planned
11 Community with Santa Cruz Properties, Inc., is not feasible and is not
12 in the best interest of the Nation and its members.

13 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that the proposed
14 San Xavier Tucson Planned Community with Santa Cruz Properties, Inc.
15 is not feasible and in the best interest of the Nation, and is there-
16 fore rejected.

17 The foregoing resolution was passed by the Tohono O'odham Council on the 27th
18 day of August, 1986, at a meeting at which a quorum was present with a vote of
19 1267.0 for; 128.5 against; 244.5 not voting; and 01 absent, pursuant to the
20 powers vested in the Council by Section 1c(2) and i(1) of Article VI and Section
21 5 of Article XVI of the Constitution of the Tohono O'odham Nation, adopted by
22 the Tohono O'odham Nation on January 18, 1986, and approved by the Acting
23 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,
24 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
