WHEREAS, The Tohono O'odham Legislative Council, having heard from the Standing Committee, has concluded that the proposed San Xavier Tucson Planned Community with Santa Cruz Properties, Inc., is not feasible and is not in the best interest of the Nation and its members.

NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that the proposed

San Xavier Tucson Planned Community with Santa Cruz Properties, Inc.

is not feasible and in the best interest of the Nation, and is therefore rejected.

The foregoing resolution was passed by the Tohono O'odham Council on the <u>27th</u> day of <u>August</u>, <u>1986</u>, at a meeting at which a quorum was present with a vote of <u>1267.0</u> for; <u>128.5</u> against; <u>244.5</u> not voting; and <u>01</u> absent, pursuant to the powers vested in the Council by Section 1c(2) and i(1) of Article VI and Section 5 of Article XVI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
