10 it does hereby approve the attached FY 87 budget of the Hickiwan
11 District and does hereby authorize expenditures from the District's
12 accounts in accordance therewith.

13 The foregoing resolution was passed by the Tohono O'odham Council on the 10th
14 day of September, 1986, at a meeting at which a quorum was present with a vote
15 of 1502.0 for; -0- against; -0- not voting; and 138.0 absent, pursuant to the
16 powers vested in the Council by Section 1 (d)(3) of Article VI of the Consti-
17 tution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
18 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
19 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
20 of June 18, 1934 (48 Stat. 984).
