(Gu Achi District Budget - FY 87)

1 WHEREAS, The Gu Achi District Council has considered and reviewed its proposed
2 activities for FY 87 and has prepared a proposed budget to cover
3 anticipated costs and expenses; and

5 WHEREAS, The Gu Achi District Council did adopt a proposed budget for FY 87 in
6 the amount of \$153,235.47 said budget period to begin on October 1,
7 1986 and end on September 30, 1987; and


8 WHEREAS, The Tohono O'odham Council has reviewed the proposed budget and
9 approves of same; and

10 WHEREAS, The Tohono O'odham Council approved for the funds to be withdrawn
11 monthly, program funds to be deposited in the Valley National Bank,
12 Casa Grande, Arizona and Personnel salaries and fringe benefits to be
13 deposited with the Tribal General account.


15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it hereby
16 approves the Gu Achi District Council budget to be expended in
17 accordance with the attached budgets.

18 The foregoing resolution was passed by the Tohono O'odham Council on the 10th
19 day of September, 1986, at a meeting at which a quorum was present with a vote
20 of 1640.0 for; -0- against; -0- not voting; and 01 absent, pursuant to the
21 powers vested in the Council by Section 1 (d)(3) of Article VI of the Consti-
22 tution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).
