

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

1 WHEREAS, The Tohono O'odham Nation is presently operating Juvenile Delinquency
2 Prevention Services under an agreement with United Way of Tucson, and

3 WHEREAS, Such services for the youth have been successful and beneficial; and

4 WHEREAS, The Tohono O'odham Legislative Council does desire to enter into an
5 agreement for services during FY'87.

7 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it
8 does support and authorize the Tohono O'odham Nation to enter into an
9 agreement with United Way of Tucson for Juvenile Delinquency Prevention
10 Services.

11 BE IT FURTHER RESOLVED that Josiah Moore, Chairman, Francisco Jose, Jr., Vice
12 Chairman, Rosita Ruiz, Treasurer of the Tohono O'odham Nation are here-
13 by authorized to negotiate and execute the agreement and any amendments
14 thereto for the duration of the agreement.

16 The foregoing resolution was passed by the Tohono O'odham Council on the 10th
17 day of September, 1986, at a meeting at which a quorum was present with a vote
18 of 1581.5 for; 58.5 against; -0- not voting; and 01 absent, pursuant to the
19 powers vested in the Council by Section 1 (f) of Article VI of the Constitution
20 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January
18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984).
