
1 WHEREAS, William A. Cameron has applied for a permit to buy cattle on the  
2 Tohono O'odham Nation; and

3 WHEREAS, The Tohono O'odham Council has found that he is in every way qualified  
4 for the issuance of a cattle buyer's permit.


6 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that it hereby approves  
7 the issuance of a cattle buyer's permit to William A. Cameron pursuant  
8 to the provisions of the Tohono O'odham Nation and federal law.

9 The foregoing resolution was passed by the Tohono O'odham Council on the 10th  
10 day of September, 1986, at a meeting at which a quorum was present with a vote  
11 of 1332.0 for; 180.0 against; 128.0 not voting; and 01 absent, pursuant to the  
12 powers vested in the Council by Section 1 c(1) and d(4) of Article VI of the  
13 Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
14 on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
15 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
16 of June 18, 1934 (48 Stat. 984).
