RES. NO. 422-86

1 WHEREAS, The Law & Order Committee requested to delay the appointment of Judges  
2 for the Tohono O'odham Judiciary, and

3 WHEREAS, The Law & Order Committee did receive additional applicants for these  
4 positions; and

6 WHEREAS, The Committee felt it would be in the best interest of the Nation to  
7 recommend as many qualified applicants at the next Council session;  
8 and


9 WHEREAS, The Tohono O'odham Legislative Council did not act on such request;  
10 and

11 WHEREAS, There are currently six positions filled which includes the Appellate  
12 Judges.



14 NOW, THEREFORE, BE RESOLVED that all current Judges of the Tribal and Appellate  
15 Court be appointed to serve under the New Tohono O'odham Constitution.

16 The foregoing resolution was passed by the Tohono O'odham Council on the 11th  
17 day of September, 1986, at a meeting at which a quorum was present with a vote  
18 of 471.0 for; 972.5 against; 196.0 not voting; and 01 absent, pursuant to the  
19 powers vested in the Council by Section 3 of Article XIII of the Constitution  
20 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January  
18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian  
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of  
June 18, 1934 (48 Stat. 984).


