RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Give 10 day notice to Judges as required in Constitution)

RES. NO. 423-86

1 WHEREAS, The Law & Order Committee requested to delay the appointment of Judges
2 for the Tohono O'odham Judiciary; and

3
4 WHEREAS, The Law & Order Committee did receive additional applicants for these
5 positions; and

6 WHEREAS, The Committee felt it would be in the best interest of the Nation to
7 recommend as many qualified applicants at the next Council session;
8 and

9 WHEREAS, The Tohono O'odham Legislative Council did not act on such request;
10 and

11 WHEREAS, There are current appointees serving as Judges of which some have
12 applied, were selected; and



14 WHEREAS, Their appointments were vetoed by Josiah Moore, Chairman of the
15 Nation; and

16 WHEREAS, The Council did not override such veto.


17 NOW, THEREFORE, BE RESOLVED that the Judges be informed that they are not
18 qualified and they are to vacate their office within ten days as
19 required by the Constitution.

21 The foregoing resolution was passed by the Tohono O'odham Council on the 11th
22 day of September, 1986, at a meeting at which a quorum was present with a vote
23 of 424.0 for; 1158.0 against; 58.0 not voting; and 01 absent, pursuant to the
24 powers vested in the Council by Section 3 of Article XIII of the Constitution
25 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January
26 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian
27 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
28 June 18, 1934 (48 Stat. 984).
