14 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above
15 named applicants are eligible for enrollment as members of the
16 Tohono O'odham Nation under Section 1 (a) or (b) of Article II of the
17 Constitution of the Tohono O'odham Nation, and that their applications
18 are approved, as herein above indicated.

20 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of
21 the Tohono O'odham Nation reduce this final determination in writing
22 regarding each of the foregoing applications for enrollment in ac-
23 cordance with Section 3 (c) of Article III of the Enrollment Ordinance;
24 give notice of this Council's determination in accordance with Section
25 4 of Article III of the Enrollment Ordinance; and place the names of
26 each applicant upon the membership roll of the Tohono O'odham Nation
27 in accordance with Article V of the Enrollment Ordinance.

29 The foregoing resolution was passed by the Tohono O'odham Council on the 11th
30 day of September, 1986, at a meeting at which a quorum was present with a
31 vote of 1640 for; -0- against; -0- not voting; and 02 absent, pursuant to the
32 powers vested in the Council by Section 1 of Article II and of Section 1 (h)
of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the
Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy
Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
