

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Mr. Steven J. Shupe to work on Water Code)

1 WHEREAS, On September 18, 1986 the Water Commission and Water Management Com-
2 mittee did make a report to the Legislative Council on the tentative
3 proposal for Water Code Workplan; and

4 WHEREAS, The Committees have recommended Mr. Steve J. Shupe to work on the
5 development of the Water Code with the two Committees; and


6 WHEREAS, It is in the best interest of the Nation that the contract proposal
7 with Mr. Shupe be submitted to the Legislative Council for review
8 and approval.

9 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that it does hereby
10 approve the Water Commission and Water Management to negotiate a
11 contract with Mr. Shupe to work on the development of a Water Code
12 for the Nation.


14 BE IT FURTHER RESOLVED that the contract will be reviewed and approved by the
15 Tohono O'odham Legislative Council.

17 The foregoing resolution was passed by the Tohono O'odham Council on the 18th
18 day of September, 1986, at a meeting at which a quorum was present with a vote
19 of 1244.5 for; -0- against; 237.5 not voting; and 158.0 absent, pursuant to the
20 powers vested in the Council by Section 1 (f) of Article VI of the Constitution
21 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January
22 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian
23 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
24 June 18, 1934 (48 Stat. 984).



5 either approve or disapprove it within 48 hours of submittal.


