

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(To Override Veto of Resolution No. 384-86)

RES. NO. 432-86

1 WHEREAS, The Tohono O'odham Legislative Council did by Resolution No. 384-86
2 approve of a six month interim Tribal Budget for FY 87 as well as for
3 Enrollment, Water Commission and Water Management and the approval of
4 Miss Tohono O'odham and Rodeo & Fair budgets not subject to this limi-
5 tation of an interim budget; and

7 WHEREAS, Upon presentation of Resolution No. 384-86 to the Chairman of the
8 Tohono O'odham Nation he did disapprove thereof and returning it to
9 the Council with his objections in accordance with the provisions of
10 Article VII, Section 5 of the Constitution of the Nation; and

11 WHEREAS, The Council has reviewed the Chairman's objections and after consider-
12 ation again voted to pass Resolution No. 384-86.


13 NOW, THEREFORE, BE IT RESOLVED that the Council does hereby override the
14 Chairman's veto of Resolution No. 384-86, by a vote of two-thirds
15 (2/3) of the votes cast

17 The foregoing resolution was presented to the Tohono O'odham Council on the
18 19th day of September, 1986, at a meeting at which a quorum was present and by
19 a vote of 1414.5 for; 105.0 against; 120.5 not voting; and 03 absent, did
20 override the Chairman's veto of Resolution No. 382-86, pursuant to the powers
21 vested in the Council by Section 5 of Article VII of the Constitution of the
22 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984).
