WHEREAS, The Tohono O'odham Legislative Council did by Resolution No. 384-86 approve of a six month interim Tribal Budget for EY 97 or well as for Enrollment, Water Commission and Water Management and the approval of Miss Tohono O'odham and Rodeo & Fair budgets not subject to this limi-tation of an interim budget; and WHEREAS, Upon presentation of Resolution No. 384-86 to the Chairman of the Tohono O'odham Nation he did disapprove thereof and returning it to the Council with his objections in accordance with the provisions of Article VII, Section 5 of the Constitution of the Nation; and

WHEREAS, The Council has reviewed the Chairman's objections and after consideration again voted to pass Resolution No. 384-86.

NOW, THEREFORE, BE IT RESOLVED that the Council does hereby override the Chairman's veto of Resolution No. 384-86, by a vote of two-thirds (2/3) of the votes cast

The foregoing resolution was presented to the Tohono O'odham Council on the 19th day of September, 1986, at a meeting at which a quorum was present and by a vote of 1414.5 for; 105.0 against; 120.5 not voting; and 03 absent, did override the Chairman's veto of Resolution No. 382-86, pursuant to the powers vested in the Council by Section 5 of Article VII of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
