

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(To Override Veto of Resolution No. 404-86)

RES. NO. 433-86

1 WHEREAS, The Tohono O'odham Legislative Council did by Resolution No. 404-86
2 approve a modification to the proposed Committee Structure, presented
3 by the Executive Committee of this Council; and

4 WHEREAS, The Legislative Council did adopt the modified Committee Structure
5 moving the Advisory Committees and Non-Governmental entities under the
6 Legislature and establishing a Judicial Branch placing the TERO Com-
7 mission under this Branch; and



9 WHEREAS, Upon presentation of Resolution No. 404-86 to the Chairman of the
10 Tohono O'odham Nation he did disapprove thereof and returned it to the
11 Council with his objections in accordance with the provisions of Arti-
12 cle VII, Section 5 of the Constitution of the Nation; and

14 WHEREAS, The Council has reviewed the Chairman's objections and after consider-
15 ation again voted to pass Resolution No. 404-86.


16 NOW, THEREFORE, BE IT RESOLVED that the Council does hereby override the
17 Chairman's veto of Resolution No. 404-86, by a vote of two-thirds
18 (2/3) of the votes cast.

19 The foregoing resolution was presented to the Tohono O'odham Council on the
20 19th day of September, 1986 at a meeting at which a quorum was present and by
21 a vote of 1502.0 for; -0- against; -0- not voting; and 138.0 absent, did
22 override the Chairman's veto of Resolution No. 404-86, pursuant to the powers
23 vested in the Council by Section 5 of Article VII of the Constitution of the
24 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
1934 (48 Stat. 984).



5 either approve or disapprove it within 48 hours of submittal.


