

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(To Override Veto of Resolution No. 405-86)

RES. NO. 434-86

1 WHEREAS, The Tohono O'odham Legislative Council did by Resolution No. 405-86
2 adopt the Committee Structure Recommendation and Option as follows:

- 3 1. The Appropriations Committee function within itself as in prior
4 years.
5 2. The Trust Committee be absorbed by the Budget & Finance Committee.
6 3. The O.E.D.P. be absorbed by the Commerce Committee.
7 4. The Mining Committee be absorbed by the Natural Resources
8 Committee; and


9 WHEREAS, Upon presentation of Resolution No. 405-86 to the Chairman of the
10 Tohono O'odham Nation he did disapprove thereof and returned it to
11 the Council with his objections in accordance with the provisions of
12 Article VII, Section 5 of the Constitution of the Nation; and

13 WHEREAS, The Council has reviewed the Chairman's objections and after consider-
14 ation again voted to pass Resolution No. 405-86.


15 NOW, THEREFORE, BE IT RESOLVED that the Council does hereby override the
16 Chairman's veto of Resolution No. 405-86, by a vote of two-thirds
17 (2/3) of the votes cast.

19 The foregoing resolution was presented to the Tohono O'odham Council on the
20 19th day of September, 1986, at a meeting at which a quorum was present and by
21 a vote of 1459.5 for; -0- against; 42.5 not voting; and 138.0 absent, did
22 override the Chairman veto of Resolution 405-86, pursuant to the powers vested
23 in the Council by Section 5 of Article VII of the Constitution of the Tohono
24 O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and
25 approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations)
26 on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
27 984).
