7 approves of same.


8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does

13 day of September, 1986, at a meeting at which a quorum was present with a vote  
14 of 1502.0 for; -0- against; -0- not voting; and 138.0 absent, pursuant to the  
15 powers vested in the Council by Section 1(d)(3) of Article VI of the Consti-  
16 tution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
17 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
18 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
19 of June 18, 1934 (48 Stat. 984).
