

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(San Xavier District Budget FY 1987)

1 WHEREAS, The San Xavier District Council has considered and reviewed the proposed
2 activities for FY 87 and has prepared a proposed budget to cover
3 anticipated costs and expenses; and

4 WHEREAS, The San Xavier District Council did adopt the proposed budget for
5 FY-87 in the amount of \$130,997.00, said budget to begin October 1,
6 1986 and end on September 30, 1987; and


7 WHEREAS, The Tohono O'odham Council has reviewed the proposed budget and
8 approves of same; and

9 WHEREAS, The Tohono O'odham Council approved for the said proposed budget in
10 the amount of \$130,997.00 to be deposited into the First Interstate
11 Bank, Tucson, Arizona from the IIM Account, located in Sells, AZ.


12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it hereby

20 powers vested in the Council by Section 1 (d)(3) of Article VI of the Consti-
21 tution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
22 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
23 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
24 of June 18, 1934 (48 Stat. 984).
