

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(San Lucy District Budget FY 1987 )

RES. NO. 439-86

1 WHEREAS, The San Lucy District Council has considered and reviewed its proposed  
2 activities for FY 87 and prepared budget to cover anticipated costs  
3 and expenses; and

4 WHEREAS, The San Lucy District Council did by Resolution on September 17, 1986  
5 1986 approve the proposed budget for FY 87 in the amount of  
6 \$44,102.64 said budget period to begin October 1, 1986 and end on  
7 September 30, 1987; and

8 WHEREAS, The San Lucy District maintains an account at the Valley National  
9 Bank, Gila Bend, Arizona and has authorized the following officers of  
10 the Council to have authority to sign checks on the account, the  
11 Chairman, Secretary-Treasurer and one Councilman; and

12 WHEREAS, The San Lucy District has sufficient funds in its IIM Account to  
13 cover the proposed budget.

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does hereby  
15 approve the attached FY 87 budget of the San Lucy District and author-  
16 zes expenditures in accordance therewith.

17 BE IT FURTHER RESOLVED that the Tohono O'odham Council does hereby authorize  
18 the San Lucy District to transfer funds on deposit in the District's  
19 IIM Account into an account with the Valley National Bank, Gila Bend,  
20 Arizona an amount not to exceed the total budget of \$44,102.64 to meet  
21 the District's budgeted expenses.

22 The foregoing resolution was passed by the Tohono O'odham Council on the 19th  
23 day of September, 1986, at a meeting at which a quorum was present with a vote  
24 of 1385.0 for; -0- against; -0- not voting; and 255.0 absent, pursuant to the  
25 powers vested in the Council by Section 1 (d)(3) of Article VI of the Consti-  
26 tution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
27 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
28 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
29 of June 18, 1934 (48 Stat. 984).
