4 the request; and


5 WHEREAS, the Budget & Finance Committee has appropriated funds from the savings

8 the Bihinol Du'ag School Board Budget.



16 tution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on  
17 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
18 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
19 of June 18, 1934 (48 Stat. 984).

failure to either approve or disapprove it within 48 hours of submittal.


