

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of loan to Kenneth Jose in the amount of \$50,000.00)

RES. NO. 446-86

1 WHEREAS, Kenneth Jose is an enrolled member of the Tohono O'odham Nation; and

2 WHEREAS, Mr. Jose is registered in Chukut Kuk District; and

3 WHEREAS, Mr. Jose has been awarded the Building and Grounds Contract for the
4 BIA, Santa Rosa Boarding School, Santa Rosa Ranch School, San Simon
5 School and the BIA Agency; and

6
7 WHEREAS, Mr. Jose secure a loan, in the amount of \$50,000.00 from First Inter-
8 state Bank; and

9 WHEREAS, Mr. Jose needs a second guarantor in order to secure such loan; and

10 WHEREAS, It is in the best interest of the Nation that an enrolled member of
11 the Nation be awarded this contract.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation does hereby
13 guarantee Mr. Jose's loan application, from First Interstate Bank, in
14 the amount of \$50,000.00.

16 BE IT FURTHER RESOLVED that this is contingent upon Mr. Jose obtaining a life
17 and wage policy securing the \$50,000.00 loan in the event of his
18 disability or demise.

19 BE IT FURTHER RESOLVED that the Nation will hold an interest in Mr. Jose's
20 business equipment until such time that Mr. Jose satisfies the loan
21 requirements.

23 BE IT FURTHER RESOLVED that Chairman, Josiah Moore or Vice Chairman, Francisco
24 Jose, Jr. are authorized and directed to negotiate and sign the
25 necessary instruments to accomplish these ends.

26 The foregoing resolution was passed by the Tohono O'odham Council on the 14th
27 day of October, 1986, at a meeting at which a quorum was present with a vote of
28 1053.5 for; -0- against; 586.5 not voting; and 01 absent, pursuant to the
29 powers vested in the Council by Section 1 (d)(5) and (f) Article VI of the
30 Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984).
