WHEREAS, the Gu Vo District Council met on October 1, 1986 to review the proposed District budget for FY 87 as prepared by the District Treasurer and the Community Budget Representatives, and the proposed use for the new Revenue Sharing Allocation; and

WHEREAS, the Budget as prepared includes funding allocations for District

Operations, Redirections Program, Pia Oik Community, Ali Chugk Community, and Gu Vo Community totaling \$84,476.00; and

WHEREAS, the District Treasurer has recommended that the new Revenue Sharing allocation, in the amount of \$13,401.00 be used to provide a final payment on the Ajo student van; and

WHEREAS, the District does have in its I.I.M. a balance in excess of \$84,476.00 and the District Council has reviewed the budgets as presented and does approve of said budgets.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that:

- 1. It hereby approves of the attached Gu Vo District Budget for FY 87 and does authorize the District Treasurer and the Community Budget Representatives to make expenditures in accordance with said budgets.
- 2. It hereby approves the proposed use of the Revenue Sharing allocation, in the amount of \$13,401.00 to provide a final payment on the Ajo student van.
- 3. The Gu Vo District FY 87 Budget be retroactive to October 1, 1986.
- 4. The District Council reserves the right to make any modifications and/or amendments to the FY 87 Budget when necessary.

The foregoing Resolution was passed by the Tohono O'Odham Council on the  $\underline{16th}$  day of  $\underline{0ctober}$ ,  $\underline{1986}$ , at a meeting at which a quorum was present with a vote of  $\underline{1640.0}$  for;  $\underline{-0}$  against;  $\underline{-0}$  not voting; and  $\underline{-0}$  absent, pursuant to the powers vested in the Council by Section 1 (d) (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
