

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Gu Vo District Budget FY 87/Revenue Sharing Budget)

RES. NO. 456-86

1 WHEREAS, the Gu Vo District Council met on October 1, 1986 to review the pro-
2 posed District budget for FY 87 as prepared by the District Treasurer
3 and the Community Budget Representatives, and the proposed use for the
4 new Revenue Sharing Allocation; and

5 WHEREAS, the Budget as prepared includes funding allocations for District
6 Operations, Redirections Program, Pia Oik Community, Ali Chugk Com-
7 munity, and Gu Vo Community totaling \$84,476.00; and

8 WHEREAS, the District Treasurer has recommended that the new Revenue Sharing
9 allocation, in the amount of \$13,401.00 be used to provide a final
10 payment on the Ajo student van; and


11 WHEREAS, the District does have in its I.I.M. a balance in excess of \$84,476.00
12 and the District Council has reviewed the budgets as presented and
13 does approve of said budgets.

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that:

- 15 1. It hereby approves of the attached Gu Vo District Budget for FY
16 87 and does authorize the District Treasurer and the Community
17 Budget Representatives to make expenditures in accordance with
18 said budgets.
- 19 2. It hereby approves the proposed use of the Revenue Sharing all-
20 location, in the amount of \$13,401.00 to provide a final payment
21 on the Ajo student van.
- 22 3. The Gu Vo District FY 87 Budget be retroactive to October 1, 1986.
- 23 4. The District Council reserves the right to make any modifications
24 and/or amendments to the FY 87 Budget when necessary.

25 The foregoing Resolution was passed by the Tohono O'Odham Council on the 16th
26 day of October, 1986, at a meeting at which a quorum was present with a vote of
27 1640.0 for; -0- against; -0- not voting; and -0- absent, pursuant to the powers
28 vested in the Council by Section 1 (d) (3) of Article VI of the Constitution of
29 the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18,
30 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs
31 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,
32 1934 (48 Stat. 984).
