7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council will

8 meet on Monday, October 21, 1986 to complete the agenda and will be

9 compensated at the rate of \$75 per Councilmember.



13 1372.5 for; 183.5 against; 84.5 not voting; and -0- absent, pursuant to the  
14 powers vested in the Council by Section 1 (a) of Article VI of the Constitution  
15 of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January  
16 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian  
17 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of  
18 June 18, 1934 (48 Stat. 984).
