

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Vacating Non Legislative Committees by November 30, 1986)

RES. NO. 468-86

1 WHEREAS, the Tohono O'Odham Legislative Council enacted Resolution No. 448-86
2 wherein members of the Legislative Council are prohibited from serving
3 on the Advisory or Non-Governmental Committees accept those speci-
4 fically listed in the resolution; and

5 WHEREAS, members of the Legislative Council currently serving on either the
6 Advisory or Non-Governmental Committees vacate their positions; and

7 WHEREAS, the resolution does not provide for a time frame for vacating their
8 positions under Resolution No. 448-86.

9
10 NOW, THEREFORE, BE IT RESOLVED that members of the Legislative Council vacate
11 their positions from the Advisory and Non Governmental Committees by
12 November 30, 1986.

13 The foregoing resolution was passed by the Tohono O'odham Council on the 20th
14 day of October, 1986, at a meeting at which a quorum was present with a vote of
15 1514.0 for; 126.0 against; -0- not voting; and 01 absent, pursuant to the
16 powers vested in the Council by Section 1 (a) of Article VI of the Constitu-
17 tion of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
18 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
19 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
20 of June 18, 1934 (48 Stat. 984).
