

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Acceptance of Executive Committee Recommendation #6)

RES. NO. 469-86

1 WHEREAS, the Executive Committee presented their "Restructuring of Committees
2 under the new Constitution" with recommendations and options to the
3 Tohono O'Odham Legislative Council on October 20, 1986; and

4 WHEREAS, the Legislative Council did review and discuss the recommendations and
5 options and have decided to adopt recommendation #6

6 "It is recommended that each member of the Legislature be re-
7 stricted to serving on no more than 4 Legislative Committees,
8 and can be the Chairperson or Vice Chairperson for only 2 of
9 them".

9 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that
10 Recommendation #6

11 "It is recommended that each member of the Legislature be re-
12 stricted to serving on no more than 4 Legislative Committees,
13 and can be the Chairperson or Vice Chairperson for only 2 of
14 them".

16 The foregoing resolution was passed by the Tohono O'odham Council on the 20th
17 day of October, 1986, at a meeting at which a quorum was present with a vote of
18 1350.5 for; -0- against; 120.5 not voting; and 169.0 absent, pursuant to the
19 powers vested in the Council by Section 1 (a) of Article VI of the Constitution
20 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January
21 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian
22 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
23 June 18, 1934 (48 Stat. 984).
