"It is recommended that each member of the Legislature be restricted to serving on no more than 4 Legislative Committees, and can be the Chairperson or Vice Chairperson for only 2 of them".

The foregoing resolution was passed by the Tohono O'odham Council on the 20th day of October, 1986, at a meeting at which a quorum was present with a vote of 1350.5 for; -0- against; 120.5 not voting; and 169.0 absent, pursuant to the powers vested in the Council by Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
