

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Acceptance of Executive Committee Option #1 of  
Recommendation #8)

RES. NO. 471-86

1 WHEREAS, the Executive Committee presented their "Restructuring of Committees  
2 under the new Constitution" with recommendations and options to the  
3 Tohono O'Odham Legislative Council on October 20, 1986; and

5 WHEREAS, the Legislative Council did review and discuss the recommendations and  
6 options and decided to adopt Option #1 of Recommendation #8.

7 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that  
8 Option #1 of Recommendation #8:

9 "Members of the Legislature shall serve on appointed Legislative  
10 Committee for as long as he/she is a member of the Legislature or  
11 resign from the appointed Committee, however Committee appointments  
be as prescribed above".

12 be adopted.

13 The foregoing resolution was passed by the Tohono O'odham Council on the 20th  
14 day of October, 1986, at a meeting at which a quorum was present with a vote of  
15 673.5 for; 560.0 against; 237.5 not voting; and 169.0 absent, pursuant to the  
16 powers vested in the Council by Section 1 (a) of Article VI of the Constitution  
of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January  
17 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian  
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of  
June 18, 1934 (48 Stat. 984).




