

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Acceptance of Executive Committee Recommendation #5)

RES. NO. 472-86

1 WHEREAS, the Executive Committee presented their "Restructuring of Committees  
2 under the new Constitution" with recommendations and options to the  
3 Tohono O'Odham Legislative Council on October 20, 1986; and

4 WHEREAS, the Tohono O'Odham Legislative Council did review and discuss the  
5 recommendations and options and have decided to adopt Recommendation  
6 #5 deleting "starting October 1, 1986" from the paragraph; and

7 WHEREAS, the amended paragraph of Recommendation #5 would read as follows:

8 "Upon the adoption of the Proposed Committee Structure, and  
9 appointment of full memberships to the Legislative committees,  
10 it is recommended that all Legislative Committees have 60 days  
11 to develop and present to the Legislative Council, Committee  
12 Plans of operation, and/or By-laws incorporating the functions  
13 identified under the Constitution for their respective Committees.  
14 With exception to the any conflicts with the new Constitution,  
15 and the adoption of any of the following recommendations the  
16 Advisory boards/commissions and the Non Governmental shall  
17 operate in accordance with existing charters.

18 ;and

19 WHEREAS, the Executive Committee would review all Legislative committees Plan  
20 of Operation, and/or By-laws incorporating the functions identified  
21 under the Constitution for their respective Committees within 30 days.

22 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that  
23 Recommendation #5 be adopted as amended.

24 BE IT FURTHER RESOLVED that the Executive Committee review all Legislative  
25 Committees, Plan of Operation and/or By-laws incorporating the  
26 functions identified under the Constitution for their respective  
27 Committees within 30 days before Council approval.

28 The foregoing resolution was passed by the Tohono O'odham Council on the 20th  
29 day of October, 1986, at a meeting at which a quorum was present with a vote of  
30 1577.0 for; 63.0 against; -0- not voting; and 01 absent, pursuant to the powers  
vested in the Council by Section 1 (a) of Article VI of the Constitution of the  
Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
1934 (48 Stat. 984).
