

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Acceptance of Executive Committee Recommendation #3)

RES. NO. 473-86

1 WHEREAS, the Executive Committee presented their "Restructuring of Committees  
2 under the new Constitution" with recommendations and options to the  
3 Tohono O'Odham Legislative Council on October 20, 1986; and

4 WHEREAS, the Tohono O'Odham Legislative Council did review and discuss the  
5 recommendations and options and have decided to adopt Recommendation  
6 #3:

7 "It is recommended that persons serving on a Legislative Committee  
8 be a member of the Legislative Council, and current non-members  
9 of the Legislature serving on Legislative Committees vacate those  
10 positions, the vacancies created be filled by members of the  
Legislature".

11 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that

12 Recommendation #3:

13 "It is recommended that persons serving on a Legislative Committee  
14 be a member of the Legislative Council, and current non-members  
15 of the Legislature serving on Legislative Committees vacate those  
16 positions, the vacancies created be filled by members of the  
Legislature"

17 be adopted.

18 The foregoing resolution was passed by the Tohono O'odham Council on the 20th  
19 day of October, 1986, at a meeting at which a quorum was present with a vote of  
20 1306.0 for; -0- against; 334.0 not voting; and 01 absent, pursuant to the  
21 powers vested in the Council by Section 1 (a) of Article VI of the Constitution  
of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January  
18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian  
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of  
June 18, 1934 (48 Stat. 984).
