Recommendation #3:

"It is recommended that persons serving on a Legislative Committee be a member of the Legislative Council, and current non-members of the Legislature serving on Legislative Committees vacate those positions, the vacancies created be filled by members of the Legislature"

be adopted.

The foregoing resolution was passed by the Tohono O'odham Council on the 20th day of October, 1986, at a meeting at which a quorum was present with a vote of 1306.0 for; -0- against; 334.0 not voting; and 01 absent, pursuant to the powers vested in the Council by Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
