
18 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that:

1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
1934 (48 Stat. 984).
