

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Go through nominations for the Rules Committee Members five positions)

RES. NO. 488-86

1 WHEREAS, the Tohono O'Odham Legislative Council were issued forms "Declaration  
2 of Candidacy for Legislative Committee Membership" and advised to  
3 select four (4) or more Legislative Committees (see Resolution No.  
4 469-86) as their preference for serving; and

6 WHEREAS, the Executive Committee received the forms completed by each Council-  
7 member indicating their interest in the ten (10) Legislative  
8 Committees; and

9 WHEREAS, the information was compiled and the results indicated that seven (7)  
10 members of the Legislative Council declared their candidacy for the  
11 Rules Committee; and

12 WHEREAS, Councilman Tony Felix withdrew his name from the membership of the  
13 Rules Committee; and

15 WHEREAS, the Legislative Council need to revote on each candidate of their  
16 choice for reappointment of membership to the Rules Committee.

17 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that nominations be  
18 reconsidered for the Rules Committee.

19 The foregoing resolution was passed by the Tohono O'odham Council on the 22nd  
20 day of October, 1986, at a meeting at which a quorum was present with a vote of  
21 651.5 for; 505.0 against; 483.5 not voting; and 03 absent, pursuant to the  
22 powers vested in the Council by Section 1 (b) of Article VI of the Constitution  
of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January  
23 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian  
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of  
June 18, 1934 (48 Stat. 984).
