(Appointment of Hiatit O'odham Policy Board)

RES. NO. 490-86

1 WHEREAS, The San Lucy District did by Resolution No. 30-86 appoint the Hiatit
2 O'odham Policy Board; and
3 WHEREAS, The Legislative Council did accept the recommendation from the San
4 Lucy District of the recommended individuals, for appointment of four
5 (4) year staggered terms; and
6 WHEREAS, It is recommended that the Hiatit O'odham Policy Board comply with the
7 60-day requirement when developing By-laws to be reviewed by the
8 Legislative Council Rules Committee.

10 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that it hereby
11 accepts the recommendation from the San Lucy District for appointment
12 of the Hiatit O'odham Policy Board.

14 The foregoing resolution was passed by the Tohono O'odham Council on the 22nd
15 day of October, 1986, at a meeting at which a quorum was present with a vote of
16 1456.5 for; -0- against; 183.5 not voting; and 02 absent, pursuant to the
17 powers vested in the Council by Section 1 (b) of Article VI of the Constitution
18 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January
19 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian
20 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of
21 June 18, 1934 (48 Stat. 984).
