

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Support of ANA Proposal)

RES. NO. 492-86

1 WHEREAS, there is a need for positive economic growth and development of the  
2 Reservation resource base; and

3 WHEREAS, Economic Development activities on the Reservation necessitate the es-  
4 tablishment and implementation of a comprehensive land use and eco-  
5 nomic development plan in order to protect and enhance the quality of  
6 the Reservation environment; and

7 WHEREAS, the Administration for Native Americans will accept proposals due by  
8 November 12, 1986; and

9  
10 WHEREAS, it is in the best interest of the Tohono O'Odham Nation to make ap-  
11 plications for ANA funding with which to accomplish a comprehensive  
12 land use and economic development plan.

13 NOW, THEREFORE, BE IT RESOLVED by the Legislative Council that it hereby adopts  
14 the following:

- 15 1. The Planning Department of the Tohono O'Odham Nation will immedia-  
16 tely direct appropriate staff to develop a grant for the purpose  
17 of securing funds in support of comprehensive land use and  
18 economic development planning from ANA.
- 19 2. The ANA proposal will include a comprehensive land use and eco-  
20 nomic development planning model.
- 21 3. The Executive Administrator will submit the proposal to the Legis-  
22 lative Council for review in the November Legislative session.
- 23 4. Various Committees should review the proposal with the Planning  
24 Department.
- 25 5. Other Organizations and Districts can also develop proposals for  
26 review in November.

27 The foregoing resolution was passed by the Tohono O'odham Council on the 23rd.  
28 day of October, 1986, at a meeting at which a quorum was present with a vote of  
29 1640.0 for; -0- against; -0- not voting; and 02 absent, pursuant to the powers  
vested in the Council by Section 1 (f) of Article VI of the Constitution of  
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,  
1934 (48 Stat. 984).
