

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Sixty day compensation for Legislative Councilmembers)

RES. NO. 498-86

1 WHEREAS, the Tohono O'Odham Legislative Council did continue to review policies  
2 and procedures recommended by the Executive Committee; and

3 WHEREAS, the matter of compensation was discussed; and

4 WHEREAS, Julia Carrillo, Schuk Toak Representative, stated that her under-  
5 standing that a fulltime Council was to be in place during this fiscal  
6 year; and

7 WHEREAS, only a few Councilmembers were appointed to four (4) Committees; and

8 WHEREAS, some members will only be compensated during the Legislative  
9 sessions and when their committees meet; and

10 WHEREAS, some members of the Council may have to seek jobs to supplement their  
11 income from the Legislature; and

12 WHEREAS, other officials of the Nation are paid an annual salary including  
13 benefits.



15 NOW, THEREFORE, BE IT RESOLVED that the members of the Tohono O'Odham Legisla-  
16 tive Council will be compensated a straight salary for the next sixty  
17 (60) days and after evaluating this matter of compensation the Council  
18 will reconsider this method of compensation.

20 BE IT FURTHER RESOLVED that this will be given to the Rules Committee to do  
21 further work on it and define those areas.

22 BE IT FURTHER RESOLVED that members of the Tohono O'Odham Legislative Council  
23 shall be paid a straight salary on a weekly basis.

24 The foregoing resolution was passed by the Tohono O'odham Council on the 28th  
25 day of October, 1986, at a meeting at which a quorum was present with a vote of  
26 1383.0 for; -0- against; -0- not voting; and 257.0 absent, pursuant to the  
27 powers vested in the Council by Section 1 (a) (d) (3) of Article VI of the  
28 Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
of June 18, 1934 (48 Stat. 984).
