(Proposed Eligibility for Indian Health Service)

RES. NO. 499-86

1 WHEREAS, the Tohono O'Odham Legislative Council has reviewed the proposed regu-  
2 tations on eligibility for Indian Health Service published in the  
3 Federal Register, June 10, 1986; and

4 WHEREAS, the Tohono O'Odham Legislative Council views such proposals as an in-  
5 fringement on the Tohono O'Odham Nation's Sovereignty and self govern-  
6 ment; and

7 WHEREAS, the Tohono O'Odham Legislative Council opposes any action which erodes  
8 the government to government relationship of our Nation to the Federal  
9 Government.



11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does  
12 hereby oppose the proposed rule on eligiblity for Indian Health Ser-  
13 vice (42 CFS, Part 36) published in the Federal Register, June 10,

January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
of June 18, 1934 (48 Stat. 984).
