

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Schuk Toak District Budget FY '87)

1 WHEREAS, The Schuk Toak District Council has considered and reviewed its
2 proposed activities for FY-87 and has prepared a budget to cover
3 anticipated costs and expenses; and

4 WHEREAS, The Schuk Toak District Council did adopt proposed budget for FY-87 in
5 the amount of \$113,500.00. Said budget to begin on October 1, 1986
6 and end on September 30, 1987; and

7 WHEREAS, The Tohono O'odham Council has reviewed the proposed budget and ap-
8 proves same.

9 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it hereby
10 approves the Schuk Toak District Council budget to be expended in
11 accordance with the attached budget.

13 The foregoing resolution was passed by the Tohono O'odham Council on the 3rd
14 day of November, 1986, at a meeting at which a quorum was present with a vote
15 of 1261.0 for; -0- against; -0- not voting; and 379.0 absent, pursuant to the
16 powers vested in the Council by Section 1 d)(3) of Article VI of the Consti-
17 tution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
18 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
19 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
20 of June 18, 1934 (48 Stat. 984).
