1 WHEREAS, The District Council of Pisinemo District did on October 18, 1986 by
2 Resolution Number 2-86, approved the attached FY 1987 Revenue Sharing
3 Budget in the amount of \$13,401.00; and

4 WHEREAS, The Pisinemo District has sufficient fund in it's Revenue Sharing
5 account as allocated by the Tohono O'odham Legislative Council for
6 FY 87 to cover the budget; and

7 WHEREAS, The Tohono O'odham Council has reviewed the attached budget and
8 approves of same.

9 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Council that it does
10 hereby approve the attached FY 1987 Revenue Sharing Budget in the
11 amount of \$13,401.00 of the Pisinemo District and authorize expendi-
12 tures in accordance therewith.

16 day of November, 1986, at a meeting at which a quorum was present with a vote
17 of 1261.0 for; -0- against; -0- not voting; and 379.0 absent, pursuant to the
18 powers vested in the Council by Section 1 (d)(3) of Article VI of the Consti-
19 tution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
20 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
21 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
22 of June 18, 1934 (48 Stat. 984).
