

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of Sells District Budget Amendment FY 87)

RES. NO. 507-86

1 WHEREAS, The Tohono O'odham Council did by Resolution No. 435-86 did approve  
2 the Sells District Budget for FY '87; and

3 WHEREAS, The Sells District did amend it's existing FY '87 budget to include  
4 \$1,500.00 for Consultant Services; and

5 WHEREAS, The Sells District does have in their IIM Account sufficient funds to  
6 cover the amended amount.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Council does hereby  
9 approve the Sells District Council Resolution to amend their Sells  
10 District budget by \$1,500.00 from \$138,000 to \$139,500.00.

11 The foregoing resolution was passed by the Tohono O'odham Council on the 3rd  
12 day of November, 1986, at a meeting at which a quorum was present with a vote  
13 of 1502.0 for; -0- against; -0- not voting; and 138.0 absent, pursuant to the  
14 powers vested in the Council by Section 1 (d) (3) of Article VI of the Consti-  
15 tution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
16 January 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
17 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act  
18 of June 18, 1934 (48 Stat. 984).
